

CARES Grant

College of The Albemarle received an allocation of \$454,857 to make available to students in the form of cash grants from the CARES (Coronavirus Aid, Relief, and Economic Security) Act.

In accordance with the CARES act language, we sent funds only to students who were Title IV eligible and were not enrolled in a fully exclusive online program as of 3/13/2020 (the date of President Trump's declaration of national emergency).

- Students enrolled in 12 or more credits during the Spring 2020 semester received the amount of \$800
- Students enrolled in 1 or more credits during the Spring 2020 semester received the amount of \$400

Note that the Department of Education required that these grants be sent directly to students and not be directed to any unpaid tuition account balances. If you have an unpaid balance, we have not deducted that from this payment. Funds were distributed to eligible students by paper check.

Reporting Requirements:

1. College of The Albemarle acknowledges that it has signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$454,857.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission May 27, is \$80,400. The *Coronavirus Aid, Relief, and Economic Security (CARES) Act* Higher Education Emergency Relief Fund provides financial support to higher education institutions for the purpose of covering expenses related to the disruption of campus operations due to the COVID-19 public health emergency. At least 50 percent of *CARES Act* funds must be used to provide emergency financial aid grants to students whose lives have been disrupted by the COVID-19 pandemic.

To be eligible for a *CARES Act* Emergency Grant, a student must:

- Be enrolled in an eligible Title IV program of study as of the Spring 2020 Term.
- Have been enrolled in at least one course in the Spring 2020 Term.
- Have completed a *2019-2020 Free Application for Federal Student Aid (FAFSA)* to verify the following general eligibility requirements. The student must:
 - Have a valid Social Security number.
 - Be a U.S. citizen or have qualifying non-citizenship status.
 - Have earned a high school diploma or GED.
 - Have registered for selective service (if the individual is male and under 26 years of age).

- Fulfill the *Satisfactory Academic Progress* standards of College of The Albemarle at the beginning of the Spring 2020 Term.
- Meet all other eligibility requirements.

HEERF III American Rescue Plan Act of 2021

College of The Albemarle received an allocation of \$1,730,464 on May 13, 2021 for the Student Portion of the funding.

College Administration approved a spending plan to ensure the students with the most need were awarded funds as well as all other students who were enrolled and met the following criteria: As of March 13, 2020 through June 10, 2021 enrolled as regular students, CCP students, Continuing Education students who had attempted 96 hours or more and other students enrolled in a curriculum class.

The amount to award was determined by the number of students who met the above criteria and then divided evenly. The College will use HEERF III Institutional funds to provide additional funds as needed.
